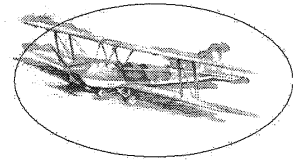

REQUIREMENTS FOR CONTRACTORS BUSINESS LICENSES
FOR THE VILLAGE OF AIRPORT DRIVE

1. COMPLETED BUSINESS LICENSE APPLICATION
2. APPLICABLE FEES
3. COPY OF YOUR IDENTIFICATION
4. COPY OF ALL APPLICABLE INSURANCES, GENERAL LIABILITY & WORKMANS COMPENSATION (IF YOU HAVE EMPLOYEES & ARE INVOLVED IN THE BUILDING PROCESS) YOU MUST HAVE WORKMANS COMP OR A SIGNED & NOTORIZED AFFIDAVIT.
5. INSURANCE CAN BE FAXED TO 417-623-7879 OR EMAILED TO apdrive@att.net (MUST HAVE VILLAGE OF AIRPORT DRIVE AS CERTIFICATE HOLDER)
6. LICENSES WILL NOT BE RENEWED UNLESS ALL FORMS ARE COMPLETED EACH YEAR ALONG WITH ALL UPDATED LICENSES AND INSURANCE DOCUMENTS.
7. YOU WILL BE RESPONSIBLE FOR GETTING ALL INFORMATION TO THE VILLAGE OF AIRPORT DRIVE OR A BUSINESS LICENSE WILL NOT BE ISSUED. IF YOU HAVE NOT RECEIVED A BUSINESS LICENSE WITHIN TWO (2) WEEKS, YOU WILL NEED TO CALL THE VILLAGE OFFICE AT 417-623-6744, TO FIND OUT IF MORE INFORMATION IS NEEDED.
